

Results of the 2017 PHA Elections

The elections were held on January 29, 2017. There were 374 PHA members out of 456 eligible members present in person or represented by proxy; this is 60% of eligible voters. The quorum for the election meeting is 30% and the election for the Officer and Trustee positions had duly taken place. The bylaws changes require 2/3 of eligible members present; as this was not the case, these changes had not been voted on.

Below are detailed results of the elections.
